5. Without prejudice to the implementation of other Community provisions relating to the classification, packaging and labelling of dangerous substances and mixtures, suppliers shall ensure, before the placing on the market, that the following requirements are met:
  - (a) lamp oils, labelled with R65 or H304, intended for supply to the general public are visibly, legibly and indelibly marked as follows: 'Keep lamps filled with this liquid out of the reach of children'; and, by 1 December 2010, 'Just a sip of lamp oil - or even sucking the wick of lamps - may lead to life-threatening lung damage';
  - (b) grill lighter fluids, labelled with R65 or H304, intended for supply to the general public are legibly and indelibly marked by 1 December 2010 as follows: 'Just a sip of grill lighter may lead to life threatening lung damage';
