4. By way of derogation, paragraph 1 shall not apply to the following substances until 4 January 2023:
 - Pigment Blue 15:3 (CI 74160, EC No 205-685-1, CAS No 147-14-8);

5. In the absence of a common ingredient name or IUPAC name, the CAS and EC number. Ingredients shall be listed in descending order by weight or volume of the ingredients at the time of formulation. "Ingredient" means any substance added during the process of formulation and present in the mixture for use for tattooing purposes. Impurities shall not be regarded as ingredients.
