If a substance listed in Appendix 13 also falls within one or more of points (a) to (g) of paragraph 1, the concentration limit laid down in point (h) of paragraph 1 shall apply to that substance.
4. By way of derogation, paragraph 1 shall not apply to the following substances until 4 January 2023:
 - Pigment Blue 15:3 (CI 74160, EC No 205-685-1, CAS No 147-14-8);
 - Pigment Green 7 (CI 74260, EC No 215-524-7, CAS No 1328-53-6).
5. "Ingredient" means any substance added during the process of formulation and present in the mixture for use for tattooing purposes. Impurities shall not be regarded as ingredients.
