Remarks

If the substance is to be placed on the market as fibres (with diameter < 3μ m, length > 5μ m and aspect ratio $\ge 3:1$) or particles of the substance fulfilling the WHO fibre criteria or as particles with modified surface chemistry, their hazardous properties must be evaluated in accordance with Title II of Regulation (EC) No. 1272/2008, to assess whether a higher category (Carc. 1B or 1A) and/or additional routes of exposure (oral or dermal) should be applied. It has been observed that the carcinogenic hazard of this substance arises when respirable dust is inhaled in quantities leading to significant impairment of particle clearance mechanisms in the lung. Classification as a carcinogen by inhalation: Mixtures in powder form containing 1 % or more of titanium dioxide which is in the form of or incorporated in particles with aerodynamic diameter $\le 10 \mu$ m.
