SECTION 4: First aid measures

4.1 Description of first aid measures



General notes

Take off immediately all contaminated clothing. Call a physician immediately. Self-protection of the first aider.

Following inhalation

Call a physician immediately. If breathing is irregular or stopped, administer artificial respiration.

Following skin contact

After contact with skin, wash immediately with plenty of water. Rub with a gel containing calcium gluconate. Immediate medical treatment required because corrosive injuries that are not treated are hard to cure.

Following eye contact

In case of contact with eyes flush immediately with plenty of flowing water for 10 to 15 minutes holding eyelids apart and consult an ophthalmologist. Protect uninjured eye. Rinse copiously with a calcium gluconate solution.

Following ingestion

Rinse mouth immediately and drink plenty of water. Rinse copiously with a calcium gluconate solution. Call a physician immediately. If swallowed danger of perforation of the esophagus and the stomach (strong corrosive effects).

4.2 Most important symptoms and effects, both acute and delayed

Corrosion, Gastric perforation, Risk of serious damage to eyes, Risk of blindness, Spasms, Dyspnoea, Circulatory collapse, Cardiac arrhythmias

4.3 Indication of any immediate medical attention and special treatment needed

Treat symptomatically. Supervise the blood circulation. Symptoms may develop several hours following exposure; medical observation therefore necessary for at least 48 hours. An immediate cleansing of the skin is urgent due to the fast absorption of the substance through the skin.

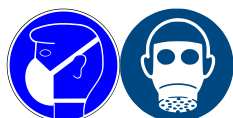

If the name of a substance, used as ingredient within the meaning of this entry, is already required to be stated on the label in accordance with Regulation (EC) No 1272/2008, that ingredient does not need to be marked in accordance with this Regulation;
