 - the relevant generic concentration limit specified in Part 3 of Annex I of Regulation (EC) No 1272/2008.
 Without prejudice to the implementation of other Community provisions relating to the classification, packaging and labelling of substances and mixtures, suppliers shall ensure before the placing on the market that the packaging of such substances and mixtures is marked visibly, legibly and indelibly as follows:
