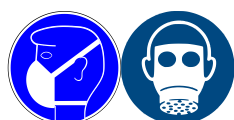

  - Shall not be placed on the market if they contain a colouring agent, unless required for fiscal reasons, or perfume, or both, if they:

    - present an aspiration hazard and are labelled with H304.

If the name of a substance, used as ingredient within the meaning of this entry, is already required to be stated on the label in accordance with Regulation (EC) No 1272/2008, that ingredient does not need to be marked in accordance with this Regulation;
    - (d) the additional statement "pH regulator" for substances falling under point (d)(i) of paragraph 1;
