7. Suppliers placing a mixture on the market for use for tattooing purposes shall ensure that, after 4 January 2022, the mixture is marked with the following information:

(a) the statement "Mixture for use in tattoos or permanent make-up";

(b) a reference number to uniquely identify the batch;
